Report of Stated Clerk

Presbytery approved the following:

- Request from the Committee on Preparation for Ministry to waive the requirement of one year of candidacy for Kevin Brunk so that he may be eligible to receive a call from Peaks Presbytery to serve the Bedford Presbyterian Church of Virginia as an Associate Pastor. Kevin was received as a candidate by New Hope Presbytery on October 19, 2002.
- Commissions for installation/ordination were given permission to add additional persons to complete the commission.

Report of Committee on Ministry

Presbytery approved the following calls:

1. To James Lawton to serve as Pastor of Pinetops Presbyterian Church. The effective date of the call is June 1, 2003. Terms: Salary \$24,000; Housing \$7,575; Medical Supplement \$500; Social Security \$2,511; Pension/Medical \$9,683; Accountable Reimbursement \$3,000. Total \$48,019. Four weeks vacation. Two weeks continuing education.
2. To Daniel Dieth to serve as Associate Pastor of White Memorial Presbyterian Church, Raleigh. The effective date of the call is July 1, 2003. Terms: Salary \$22,625; Housing \$22,724; Social Security \$3,477; Pension/Medical \$13,407; Accountable Reimbursement \$3,000. Total \$63,333. Four weeks vacation. Two weeks continuing education.
